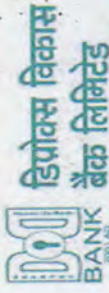

# Editorial

The year 2006-2007 was a very eventful and successful year for Nepal AOTS Alumni Society. It was also the year that marked the golden jubilee year of establishment of Nepal-Japan diplomatic relationship, and along with different Japan-related institutions, NAAS also participated in a number of events and programs to celebrate the year-long occasion. The presence of the eminent quality guru Prof. Noriaki Kano and his keynote address had enhanced the prestige of the convention.

A new executive body was elected by the NAAS AGM last year. Mr. Prakash Raj Suwal, the incumbent president succeeded Ms. Amira Dali who had successfully led the society to great heights. The 7th Convention of the AOTS Alumni Societies was held in Mumbai, India in September 2006, and three members of NAAS led by Prof. Dinesh Chapagain participated in the two-day convention. In the SAFAAS meeting held as part of the AOTS convention, NAAS has been elected vice-president for two years, and it was decided to hold the SAFAAS convention in November 2007 in Lahore, Pakistan.

This year, NAAS is organizing the Nepal-Japan IT Business Promotion Convention in July coinciding with the 17th AGM. The IT convention is another path breaking effort of NAAS – this time hoping to open up an interaction to explore the potential for initiating IT business between Nepalese and Japanese entrepreneurs/business organizations.

This 17th issue of TALIM carries the keynote address of the chief IT expert and abstracts of different papers being presented by Japanese and Nepalese resource persons in the IT convention. Besides the regular features and information on NAAS activities, this issue also covers the 4th Regional Quality Convention held in Kathmandu and the 7th AOTS Convention held at Mumbai, India. We hope you find this issue interesting. We express our deep gratitude to the advertisers and contributors and all those that made it possible to bring out this issue to you on time.

Nepal AOTS Alumni Society (NAAS) is a non-government organization of the ex\_trainees of the Association for Overseas Technical Scholarship (AOTS), Japan. NAAS was formally established in 1991 with the following objectives:

- ♦ Human resource development in management and technical fields in Nepal.
- ♦ Conduct various activities in line with its parent AOTS, Japan.
- ♦ So far, 500 Nepalese have already received training in AOTS, Japan and more than 2,300 have received training in Nepal. NAAS has its own training center, the Yamamoto Talim Ghar at Koteshwor, Kathmandu. NAAS VISION 2000 has focused on two specific areas:
- ♦ For IT, Nepal AOTS Computer Training Center (NACTC) is the focal agency.
- ♦ For Quality, Nepal AOTS Japanese Style Management Training Centre (JASMAN) is the focal agency.



## The Association for Overseas Technical Scholarship (AOTS)

AOTS was established in Japan in 1959 with the support of Japan's Ministry of Economy, Trade and Industry (METI). Its main objective are to:

- ♦ Promote technical cooperation between Japan and developing countries for the industrialization and development of developing countries.
- ♦ Enhance mutual and friendly relationships between those countries and Japan.
- ♦ Support various educational and training activities of alumni association like NAAS.

Till date, AOTS has trained approximately 2,88,000 persons in Japan from 150 countries and regions. The activities of AOTS are financed by Japanese government subsidy, company contributions, and other sources.

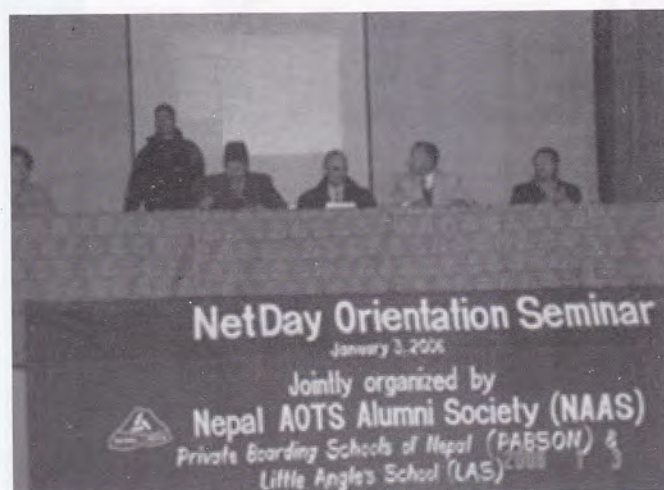

## NetDay Orientation Seminar



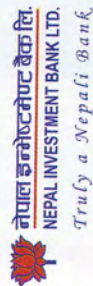

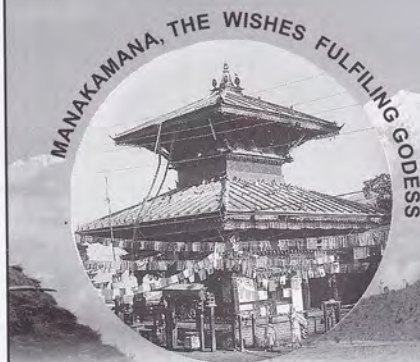
## Meeting with Mr. Masafumi Sato at YTG

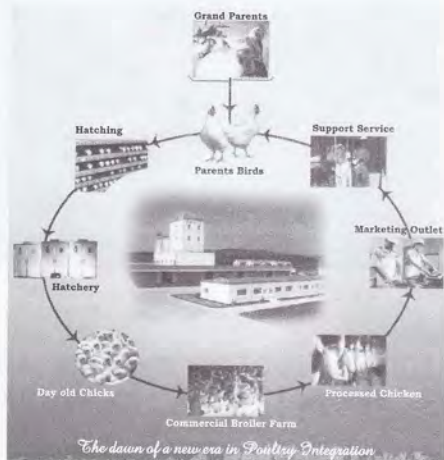

# Seventh Convention of the AOTS Alumni Societies held on 11-12 September 2006, Mumbai, India

A three-member delegation of Nepal AOTS Alumni Society led by Prof. Dinesh Chapagain (Advisor), Mr. Ramesh M Singh (Vice President) and Ms. Shanti Chapagain (Member) attended as Representative, Assistant Representative and Member of Delegation respectively in the 7th Convention of the AOTS Alumni Societies held on 11-12 September 2006 at Hotel Intercontinental the Grand, Mumbai, India.

The opening session of the Convention was held in great fanfare amidst traditional music and classical dances. The inaugural session started at 9:30 a.m. with the welcome address by Mr. M. R. Ranganathan, President, Federation of AOTS Alumni Association of India (FAAAI) and introductory address by Mr. M. M. Ramamurthy, President, AOTS Alumni Association of Western India (AAAWI). Mr. Shugi Ogawa, President, AOTS, Japan delivered the opening address followed by the presidential address by His Excellency Mr. Yasukuni Enoki, Ambassador of Japan to India. Mr. Toshikazu Kumazawa, Senior Managing Director, AOTS, Japan read out a special message of Honorable Minister for Justice, Government of Japan, Mr. Seiken Sugiura. His Excellency Governor of Maharashtra, the chief guest, delivered his inaugural address after inaugurating the Convention by lighting the *panas* and released the 7th Convention Commemorate Souvenir. All participants and delegates of the convention then gathered in the hotel lawn for group photograph.

The Convention was divided into a number of programmes such as the general assembly, group meetings, meetings of regional federations, WNF management committee meeting, a special presentation by the AOTS alumni of Singapore, and reporting of different meetings and adoption of convention resolution.

The first part of the General Assembly started with the selection of chairpersons and other officers of General Assembly and group sessions and adoption of Convention agenda. **Group D –** “Management of WNF and collaboration with non-ODA funded AOTS programs”

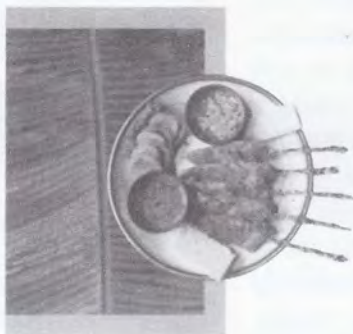

# Organizing Net Day in Nepal

## What is NetDay?

Conceived as a grassroots drive to help bring elementary and secondary schools in the Internet regime in an economical manner using a combination of public volunteers and private contributions, the concept of NetDay that started in 1996 in California, USA has spread internationally since then. NetDay's mission is to connect children to a brighter future by helping teachers meet educational goals through the effective use of Educational Technology and Information and Communication Technology (ICT).

## Helping Schools Use ICT and NetDay

Nepal AOTS Alumni Society (NAAS) initiated NetDay in Nepal in 2004 with the assistance of Mr. Yoshiaki Hayasaka, then Senior JICA Volunteer in Nepal after NAAS was granted 50 Notebook computers on donation from Toyonaka International Friendship Association (TIFA), Japan. After launching the first NetDay project on 1st January 2005 at Shanti Nikunja High School, Kathmandu, the Nepal-Japan IT Promotion Committee of NAAS has implemented NetDay in five more schools. NAAS has donated 10 computers to each of the schools under the NetDay project.

The NetDay has been designed to be celebrated in a two-day program in respective schools. On the first day, students and volunteers are briefed about the tasks to be carried out and different teams are formed for the tasks of Network Construction, Network Test, Server Installation, Camera Document, Event Management, Registration, Stage Management. On the second day, network cabling is installed in all classrooms, office rooms, and the library so that individual computers can be plugged

in and used to access internet facility. On both days, the program starts with everybody performing the popular "**Namaste Byayam**", a physical exercise consisting of different Nepalese dance motions, yoga etc. During the closing ceremony on the second day, after demonstration of Internet connectivity (network testing and web site search and information), computers are handed over to the schools. At the end of the program, all present lend their hands in cleaning the school premises before leaving.

Technically, the first lot of 10 computers was handed over to the first school only after four months due to procedural difficulties in importing the 50 computers from Japan. Due to such difficulty, NAAS decided to mobilize more computers at the local level by soliciting different companies and organizations to take the program further to more schools. In this pursuit, NAAS received 12 desktop computers from Nepal Investment Bank in October 2006.

## NetDay Celebrations



The first NetDay was celebrated as planned at **Shanti Nikunja High School**, Maruhiti, Kathmandu on 31 December 2004 and 1 January 2005. A NetDay memorial photograph was taken at the end. On 13 April 2005, NAAS organized a "Thanks Giving" function during which H. E. Ambassador of Japan, Mr. T. Hiraoka inaugurated the video program on the first NetDay and

also handed over ten Notebook computers to Shanti Nikunja Madhamik School.

The second NetDay was held on 22 and 23 July 2005 at **Kanti Ishwari Shishu Vidyalaya**,

The third NetDay was held on 26 and 27 August 2005 at **Tri-Padma Vidyashram Higher Secondary School**, Pulchowk, Lalitpur.

The fourth NetDay was held on 9 and 10 September 2005 at **Kanya Mandir Higher Secondary School**, Chhetrapati, Kathmandu.

The fifth NetDay was held on 30 September and 1 October 2005 at **Shanti Shikshya Mandir**, Thahity, Kathmandu.

After a long gap, the sixth NetDay was held on 9 and 10 September 2006 at **Balsewa Madhyamic Vidhyalaya**, Jhochhen, Kathmandu.

After distributing all the imported Notebook computers to different schools, NAAS IT Committee planned to start NetDay in private and boarding schools where computers need not be donated by NAAS since most of these schools are already equipped with computers through their own resources. Only the concept of NetDay was required to be initiated in these schools. The idea was to propagate NetDay wherever possible with and without donation of computers.

### Computer Handover

For the first time, NAAS IT committee planned to visit schools outside the Kathmandu Valley to help them to use computers and extend the NetDay program there. In this context, a number of desktop computers have already been handed over to the following schools amidst



brief handover functions in the presence of school management board, students and local community leaders.

**Shree Saraswati Higher Secondary School**, Bhotechaur-1, Sindhupalchok District on October 28, 2006

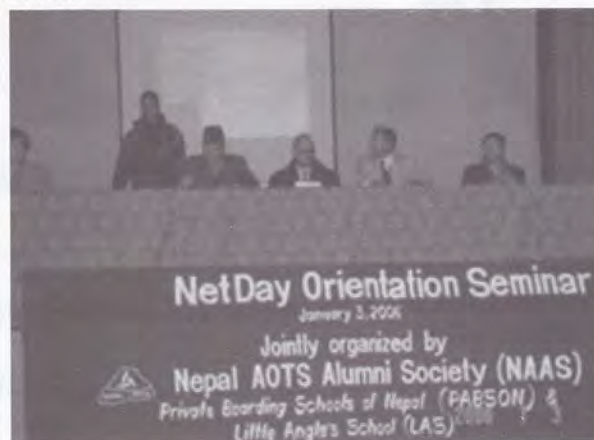
NAAS has assured to train teachers and staff of the respective schools on Internet and other necessary computer programs in Kathmandu itself since it was difficult for our trainers to visit the individual schools. NAAS hopes to train a sizeable group of staffs from outside the Kathmandu Valley in the near future.

### Computer Training

To supplement the NetDay programs, on January 2, 2005, NAAS provided training on Web Page Designing, Email and Internet to ten teachers and staffs of five schools of Kathmandu selected for NetDay. The main objective of the training program was to prepare the participants to develop the capabilities of web page designing and prepare web pages of their respective schools.

### Orientation Seminar

A NetDay Orientation Seminar was held on January 3, 2006 at Little Angle's School, Hattiban, Lalitpur. During this seminar, amidst a gathering of a number of schools, members of NAAS IT committee and principals of all five schools shared their experiences of NetDay at the respective schools. The objective of this seminar was to inform interested schools about the concept of NetDay, to explore prospects of expanding NetDay programs, and to organize NetDay in series of schools.

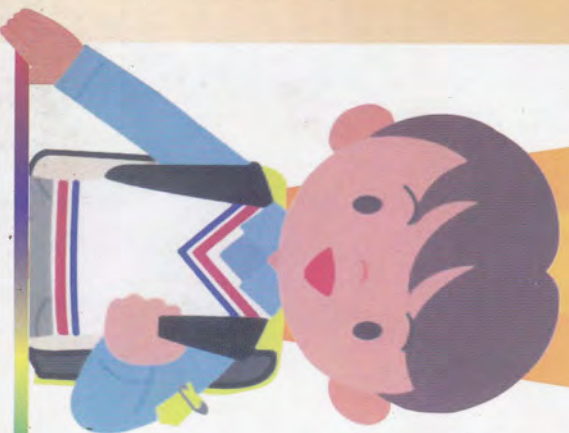
