50 Years of Establishment of Nepal-Japan Diplomatic Relationship

On September 1, 1956 notes agreeing to establish diplomatic relations between Japan and Nepal at ambassadorial level were exchanged in New Delhi whereby the respective ambassadors in New Delhi were accredited to each other's country as ambassadors, pending the appointment of separate resident ambassadors. Later, Royal Nepalese Embassy was established in Tokyo in 1965 with H.E. Mr. Bharat Raj Rajbhandari as the first Nepalese residential ambassador. Similarly, Japanese Embassy was established in Kathmandu in 1968 and H.E. Mr. Hidemichi Kira assumed his office as the first residential Ambassador of Japan to the Kingdom of Nepal. However, the history of friendly and cordial relations between the two countries stretch back over a century since Rev. Ekai Kawaguchi, the first recorded Japanese visitor to Nepal, entered this Himalayan Kingdom on his way to Tibet in search of holy Buddhist scriptures in 1899. In 1902, the Government of Nepal sent eight promising young Nepalese students to Japan to study various courses in Engineering and Technology. They returned to Nepal in 1905 and rendered useful and important services in the development of Nepal.

The cordial bilateral relationship has been marked by an exchange of visits at the highest level between the imperial and royal families, high level government officials such as cabinet ministers, parliamentarians, and senior officials of different ministries from both countries. Exchange of visits made between the prime ministers of both the countries, namely Girija Koirala in November 1998 and Yoshiro Mori in August 2000 was another milestone in the friendly relations.

Both countries share a lot of things in common – the common Asian heritage has bound the people of the two countries through a spiritual and cultural link. Similarities are found in terms of culture, religion and nature of sentiments and values.

Over the last fifty years, Japan has been an active partner in Nepal's development programs. Soon after the diplomatic relations were established in 1956, Japan has

been extending technical and economic cooperation for the uplift of socio-economic development of Nepal covering the fields of health, education, energy, transport, drinking water, environmental conservation etc. Beginning with a modest technical assistance in the form of services of expertise and consultancy, from 1968 onwards, technical and financial assistance had been extended followed by the arrival of JCVC, JICA and large project aid. Till 2004, the Government of Japan has provided a total assistance of 281 billion yen to Nepal which consists of 165.6 billion yen grants, 51.5 billion yen in technical assistance and 65.9 billion yen in loans. The Japanese Government has been extending technical cooperation to Nepal through its Official Development Assistance (ODA) program.

Japan is one of the major trade partners of Nepal. In 2004/05, Nepal imported Rs. 2.7 billion worth of goods, mainly machinery and vehicles, from Japan while it exported goods such as carpets, pashmina and other handicraft items worth Rs. 535 million. Private investment from Japan has been mainly concentrated in the tourism sector due to the large number of tourists and visitors coming from Japan. Japan is presently the sixth biggest investor in Nepal with 102 cases of direct investment accounting to Rs. 1040.4 million (2004/05). Some Japanese companies have established joint ventures with Nepalese companies in the field of ICT. Many Japanese tourists have been attracted to Nepal by its diversity of natural beauty, rich cultural heritage, exotic wildlife and hospitable people. Japan has been one of the largest tourist generating countries and some 41,000 Japanese visited Nepal in 2000.

Japan had begun accepting several Nepalese trainees under the Colombo Plan in 1954 itself. In recent years, a large number of Nepalese students have been receiving opportunities of higher education in Japan under government and non-government scholarship programs.

Human resource development is an important area of cooperation. Japan has been sending technical experts

and overseas volunteers to Nepal, and the same time accepting Nepalese trainees for training in Japanese institutions, Association for Overseas Technical Scholarship (AOTS) has been accepting a number of Nepalese trainees in technical and management fields for various training programs at Japan. The first Nepali trainee went for AOTS training almost 40 years ago. The main objective of AOTS is promotion of cooperation and economic development of developing countries through human resource development. In 1990, the ex-trainees of AOTS, Japan established the Nepal AOTS Alumni Society (NAAS) following similar objective of human resource development through cooperation with AOTS

and its different alumni societies all over the world. Nepal AOTS Alumni Society has been actively involved in the conducting various domestic training programs through its own resource persons, sending Nepalese trainees to Japan, inviting Japanese quality management experts and exchange of trainees with regional alumni societies. The major focus is the development of human resources in the private sector. It is also involved in organizing seminars and conventions to promote quality management in the country. So far, about 500 Nepalese have been trained in various programs in Japan and more than 2300 trained in Nepal with the support of AOTS Japan. This is another dimension of Nepal-Japan cooperation. □



About Nepal AOTS Alumni Society

Nepal AOTS Alumni Society (NAAS) is a non-government organization of the ex-trainees of the Association for Overseas Technical Scholarship (AOTS), Japan. NAAS was formally established in 1991 with the following objectives:

- Human resource development in management and technical fields in Nepal.
- Conduct various activities in line with its parent AOTS, Japan.
- So far, 500 Nepalese have already received training in AOTS, Japan and more than 2,300 have received training in Nepal. NAAS has its own training center, the Yamamoto Talim Ghar at Koteshwor, Kathmandu. NAAS VISION 2000 has focused on two specific areas:
- For IT, Nepal AOTS Computer Training Centre (NACTC) is the focal agency.
- For Quality, Nepal AOTS Japanese Style Management Training Centre (JASMAN) is the focal agency.



The Association for Overseas Technical Scholarship (AOTS)

AOTS was established in Japan in 1959 with the support of Japan's Ministry of Economy, Trade and Industry (METI). Its main objectives are to:

- Promote technical cooperation between Japan and the developing countries for the industrialization and development of developing countries.
- Enhance mutual and friendly relationships between those countries and Japan.
- Support various educational and training activities of alumni associations like NAAS.

Till date, AOTS has trained approximately 2,88,000 persons in Japan from 150 countries and regions.

The activities of AOTS are financed by Japanese government subsidy, company contributions, and other sources.

Application of QFD for Product and Process Improvement In Pakistani Organizations

QFD is a powerful management tool to translate the voice of customer into product and services. It is systematic methodologies to obtain, analyze, classified, rated and prioritize voice of customer and then matched with the quality, function, design and process specs. Over the last few decades, the business environment has changed dramatically. Most businesses are no longer organized to compete effectively. This study explains the basic elements of QFD and aims to prove the applicability of this theory to organizations for product & process

improvement via conducting a research by doing so it attempts to show that the quality can be increased. This study also shows that QFD is a comprehensive framework, which incorporates to certain, extends other TQM tool such as FMEA, SPC, DOE, and 7 New Management Tool etc. Finally in this paper, building house of quality, which is an important tool of QFD, will be presented with a case study from the process industry. This case study shows how successfully this concept can be implemented in Pakistani organizations. □

Integration and Implementation of Food Safety Management Systems

Food Safety is related to the presence of food-borne hazards in food at the point of consumption. The food safety hazards can be introduced at any stage of the food chain, adequate control throughout the food chain is essential to prevent occurrence. The HACCP system is state of art management technology that systematically identifies specific hazards and control measures to ensure the safety of food products. The system has been recognised world-wide and accepted as an effective system for safety management of food products. The system requirements are generic and applicable to all food organisations concerned with the food chain from production preparation, processing, packaging, storage and distribution until the point of consumption. The HACCP consists of the seven principles, like conduct

hazard analysis, determine the Critical Control Points (CCPs), establish critical limit(s), establish a system to monitor control of the CCPs, establish the corrective action to be taken when monitoring indicates that a particular CCP is not under control, establish documentation concerning all procedures and records appropriate to these principles and their application, and establish procedures for verification to confirm that the HACCP System is working effectively. The aim of this International Standard is to harmonize globally the requirements for Food Safety Management within the food chain. It also requires organisation to meet any applicable food safety related statutory and regulatory requirements through its food safety management systems. □

The Shifting Role of Educational Institutions in Providing the Extra-curricular Value Addition: *"Competitive Skills for Survival"*

In the next few decades, the developing economies will be increasingly driven in two lucrative avenues of earning foreign exchange: Business Process Outsourcing and Providing Globally Employable Individuals (GEI).

The paper defines the value-adding skills which are necessary to transform individuals (having formal higher education) into GEIs, and for them to survive in the global markets. The quest for high quality education and skills-training to meet the demands in above scenario is expected to set up a series of chain reactions among various stakeholders (parents, students, institutions and the governments). The roles expected of these

stakeholders particularly education systems' response to changing demands of industry, are discussed.

The appropriate platform for imparting any value-adding skills appears to be the educational institutions themselves. They will need to impart them in order to make their students globally employable. It is unlikely that employers will invest in resources to do so, especially if those skills make the trained personnel more attractive to competitors.

An ideal format of an institution's working is suggested to impart the skills and to develop the "dare-to-be-different" attitude. □

When things go well, cultural differences seem interesting, adding spice and variety to the workplace especially when there are few demands placed upon them. But when stress is introduced, like deadlines, production and sales targets, and tight budgets the situation changes very quickly. Unless acknowledged and addressed, cultural differences can prevent the job from getting done. From the perspective of 33 Filipino staff, supervisors and middle managers working for Japanese firms in the Philippines, this paper explores their views on the positive and negative work traits of fellow

Filipinos and their Japanese bosses and peers. It also identifies potential areas of misunderstanding between the two groups, i.e. their values and beliefs on concepts of time, company loyalty, teamwork, communication, decision-making, etc. In the end, the paper suggests that organizations seriously consider developing cross-cultural management skills in their people as a competitive advantage. Ultimately, for any management intervention or strategy, such as total quality management (TQM), to be successful, one has to work with and work through people regardless of their cultural orientation. This is the essence of management. □

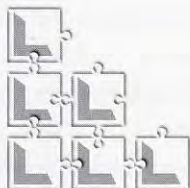

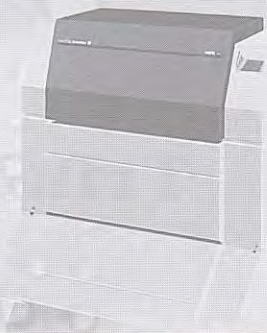

Food Safety and Quality System In Nepal

Basis of food safety and quality control system are Food Law and Regulation, Food control management, Inspection services, Laboratory services and information, education, communication and training. The Department of Food Technology and Quality Control is the central government agency implementing food safety and quality control programme to ensure safe and quality food to the consumer.

The traditional model of end product testing to ensure the safe and quality food has been changed into in-process testing. The case study on perishable food products like milk and meat products industry showed that the end product testing is not a sole remedy to assure the safety and quality of the food products. The

development of food safety and quality system needs to address the root cause of deterioration of safety and quality food throughout each and every step of food chain from farm to fork.

The chain is becoming more complex due to greater integration and significance for farmers, producers as well as the consumers. The system incorporating specifications, traceability, code of practice and food safety management system is becoming safer to ensure food safety, legality and quality. This approach emphasizes on the preventive measures through appropriate management system. This paper outlines the legal system, food control system and preventive approach adopted within the food chain in Nepal. □

Trans-boundary movement of goods and services depends upon reciprocal recognition and acceptance of conformity assessment activities like inspection, test and certification. In this paper, summary status of management system (QMS, EMS / HACCP) certification and product certification which are directly identifiable and verifiable by the mark of conformity are highlighted. The mark of conformity for the management system is the logo of certification body and accreditation body that can be publicized but cannot be put on the product. Similarly, the mark of conformity for the products

quality is the quality certification mark on the product itself. Here, in this paper the name of the organization, product and service sector, type of certified management system and the names of certification agencies are highlighted.

With regard to certification system sectorial trend has been analyzed. Similarly, in case of product certification, name of the organization and product sector have been highlighted. Also, this paper provides an overview of certification agencies operating in Nepal. Attempt has also been made to identify the organizations whose management systems as well as product are certified. Lastly, information has been provided regarding mandatory standard for industrial products. □

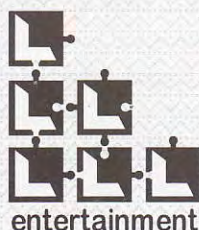

Milk and milk products are getting wide acceptance by general consumers day by day. In the meantime, the challenge of providing safe and hygienic milk and milk products is standing ahead in the Nepalese context. At this juncture, the public sector organization Dairy Development Corporation- Kathmandu Milk Supply Scheme (DDC-KMSS) has taken bold steps to implement international level standard, i.e Quality Management System requirements (ISO 9001:2000) and Hazard Analysis and Critical Control Point (HACCP) warranty in an integrated manner. The organization has implemented the system with highly appreciable commitments from the top management to floor level employees. The quality and food safety policy has been formulated and consistent objectives in line with the policy have been derived through wide discussion and involvement of various levels of employees. The steering committee headed by Management Representative (MR) and HACCP team have facilitated the implementation of both the projects through and integrated approach. In addition, the consulting firm QEMS (Quality and Environmental Management Service) Kathmandu has added very

valuable inputs and facilitated DDC management to accomplish this project successfully. Customer feedback, product recall, procedures, review of management system, providing resources to the system including training and development customer and supplier relationship, promotion of Quality system outside DDC etc. have been focused on priority basis while implementing the system. Obviously being a government undertaking on the one hand, it may be easier for the organization to invest in infrastructure and development if the decision maker is highly committed. On the other hand some bureaucratic hurdle may exits if traditional approach is adopted in the decision making for implementation of these standards. In conclusion, the present achievement of the DDC-KMSS should be able to give continuity to maintain and improve the system, since there is still a lot of space for improvement. DDC-KMSS should shoulder the responsibility of implementing the same system in other units and chilling centers etc. The DDC-KMSS, Balaju has been already certified with ISO 9001:2000 and HACCP. □
