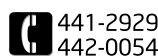

# NEPAL AOTS ALUMNI SOCIETY

Nepal AOTS Alumni Society, a non-governmental organization of the ex-trainees of the Association for Overseas

Technical Scholarship (AOTS), Japan has been actively involved in promoting human resource development in management and technical fields in Nepal since its formal establishment in 1991. So far, around 795 Nepalese have received training in AOTS Japan and about 3000 in Nepal.

AOTS is a non-profit association established in 1959 with the support of the Japanese Ministry of Economy, Trade and Industry (METI) with the objective of promoting technical cooperation between Japan and the developing countries for the industrialization and development of developing countries. AOTS has been supporting the human resource development efforts of Nepal AOTS.

Since its establishment, Nepal AOTS Alumni Society has been engaged in the development of Nepalese human resources in the following ways.

- Nominating appropriate Nepalese candidates for various types of training programs in Japan
- Organizing training/seminar/workshop programs in Nepal with resource persons from Japan and South Asian countries
- Organizing training/seminar/workshop programs in Nepal with Nepalese trainers among the resource pool of Nepal AOTS members and/or other experts

## iv) Collaboration based training program with FNCCI

Since its establishment in 1959, AOTS has been conducting various technical and management training programs in Japan for the people of developing countries

and other regions. The total number of participants in past AOTS training programs amounts to almost 155,000 from about 170 developing countries and regions. These former participants are playing very important roles in industry and contributing greatly to the economic development of their respective countries.

At the request of former participants of AOTS training programs as well as the industrial and business circles in developing countries, AOTS has been organizing various training programs.

The "Program on Corporate Management for Nepal" (NPCM) is one of such management training programs, which is being organized in collaboration with Nepal

AOTS Alumni Society (NAAS) and Federation of Nepalese Chambers of Commerce & Industry (FNCCI), mainly designed for CEOs and senior executives of SMEs in order to improve the managerial capabilities of corporate executives in Nepal.

Since 2009, about 80 Nepalese have participated in the special NPCM program – 30 candidates in 2009, 50 in 2010-2011. Recruitment process for 20 more candidates for the program in 2012 is already in progress. Likewise, two batches of Nepalese IT professionals recruited under the aegis of FNCCI were trained under AOTS Japan in early last decade.



## THE ASSOCIATION FOR OVERSEAS TECHNICAL SCHOLARSHIP

AOTS was established in Japan in 1959 with the support of Japan's Ministry of Economy, Trade and Industry (METI).

Its main objectives are to:

- Promote technical cooperation between Japan and the developing countries for the industrialization and development of developing countries.
- Enhance mutual and friendly relationship between

those countries and Japan.

- Support various educational and training activities of alumni associations like NAAS.

Till date, AOTS has trained approximately 300,500 persons in Japan from 150 countries and regions.

The activities of AOTS are financed by Japanese government subsidy, company contributions and other sources.



## WORLD NETWORK OF FRIENDSHIP (WNF)

The World Network of Friendship (WNF) was formed with the consensus of all AOTS Alumni Societies during the 5th Convention of AOTS Alumni Societies

held in Aichi, Japan in September 1997 with an initial fund raised through different sources commenced by a personal contribution of 5 million Yen by former AOTS President Mr. Nagaaki Yamamoto. Earlier to the formation of WNF, there was the Inter-Alumni Society Resource Exchange Program. However, the basic guidelines were drawn in the second steering committee meeting held in Dhaka, Bangladesh in November 1998, which was then revised by the WNF Management Committee at the third meeting held in Kuala Lumpur, Malaysia in December 2001.

WNF's mission statement is "The creation of a better world through the ties of friendship and the individuals as well as collective endeavor of our members". To implement this mission, WNF seeks to empower individuals and organizations in developing countries that are committed to the social and economic development of their own communities, based upon a belief in self-help and equal-partnership, through human resources development, exchanging information and learning from each other's experiences.

With this entire endeavor, WNF program can be beneficial to the countries in the region and will certainly be an effort to attain the aim stated in the WNF resolution

### Highlights of SAFAAS Convention 2011

1. About 200 participants from Bangladesh, India, Iran, Nepal, Pakistan, Sri Lanka, Japan, Brazil, Bulgaria, China, Egypt, Philippines, Sudan, Turkey and few others will participate in the convention to be held at Soaltee Crowne Plaza.
2. The convention is being organized with the theme *"Regional Collaboration for Coexistence and Growing Together with Japan"*. We feel that the theme should hold significance to the context of regional cooperation and collaboration for mutual economic development with an important role of Japan for promoting intra and inter-regional economic diplomacy in South Asia. Countries like India have grown economically strong with a strong presence of Japanese technological

Dr. Ryokichi Hirono, Professor Emeritus, Seikie University, Chair, Environmental Partnership Council of Japan and Adviser to the Asian Association of Management Organisations, now Visiting Professor at National Graduate Institute for Policy Studies (GRIPS), Tokyo, holds various public positions at home and overseas and involves in the board of different research, academic bodies and civil society organizations in Japan and overseas. He graduated from the University of Chicago in 1958. Dr. Hirono has worked as the Chair of the Committee for the Development Policy of the United Nations Economic and Social Council, helped integrating social and economic development at UNESCAP in Bangkok. He also worked for the OECD/DAC in Paris, ADB in Manila as Vice President of Japan Evaluation Society, and initiating UNDESD as advisor to Prime Minister Koizumi, at WSSD, Johannesburg, South Africa in 2002. There are over 600 books and articles to his credit.

4. Participation of representatives of 5 other federations of Latin America, Africa, Europe, China and East Asia, and observers from new alumni societies from the Middle East, Central Asia and Africa.
5. Business2Business (B2B) meetings between Nepalese entrepreneurs with interested entrepreneurs under SAFAAS member associations. FNCCI requested to be the focal point to organize the B2B interaction program.

# Forty Eight Years of Connection with AOTS

## 1. Introduction

I went to Japan on Japanese Government Scholarship in April 1961 from the then East Pakistan (now Bangladesh) and studied at Chiba University and then at the University of Tokyo from where I got BE, ME and Dr. Engg. degrees in Naval Architecture.

In April of 1963, I had the opportunity to meet Hozumi-Sensei, the founder of AOTS, at Asia Bunka Kaikan (ABK) in Komagome for the first time when I went there to see a few senior students from my same country. In March 1966, I graduated and, therefore, I had to leave Komaba Foreign Students House. With kind recommendation of my professor and also a senior of the same department named Mr. Shun Katsuyama (a staff of AOTS), Hozumi-Sensei gave me a part-time job at the Reception Desk of Yokohama Kenshu Centre (YKC) of AOTS where I shared the work-load with two other Japanese graduate students of Yokohama National University with 8 hours rotation for each. We stayed at YKC free of cost and got 50% discount at the dining hall.

During my two years stay at YKC, I came to know Hozumi-Sensei more closely and gradually respected and admired his way of thinking for the people of Asia. Finally, I also became one of his disciples sharing the “Hozumi Spirit” (the spirit of one Asia) which has been a precious asset in my life.

YKC gave me another wonderful thing which is my beloved wife Eiko who was a dining hall staff over there. The process of our marriage was indeed difficult, but it was finally possible through the kind help of Hozumi-Sensei who acted as the match-maker. Thereafter, we became yet closer to both Mr. and Mrs. Hozumi.

On completion of my Doctorate Degree in March 1971, Hozumi-Sensei gave me another opportunity to become an AOTS trainee for getting practical experience for six months at IHI Tokyo shipyard. In fact, this training helped me to become an effective teacher in the Universities in my country and then in Hong Kong, Singapore and Malaysia. Apart from teaching, I was also instrumental in establishing a strong AOTS alumni network in Bangladesh, Singapore and Malaysia.

In the early 1980s, Mr. Nagaaki Yamamoto took over the steering wheel of AOTS after Hozumi-Sensei had passed away. Many new ideas were introduced and AOTS experienced a rapid growth. New overseas offices were established including one in Bangladesh and, as a very special case, Mr. Yamamoto gave me the charge of AOTS Dhaka office in April 1986 for looking after both Bangladesh and Nepal. I retired at the end of March 2004 when AOTS Dhaka office was closed down, but I continued to work for AOTS as a person till date. In fact, AOTS is now everything in my life and I am grateful to President Kaneko for giving me this wonderful opportunity.

During the last 12 years, I was instrumental in establishing two other organizations- Japanese Universities Alumni Association in Bangladesh (JUAAB) in 2000 and Japan-Bangladesh Chamber of Commerce and Industry (JBCCI) in 2004. Since then, I have been actively involved in both of these organizations.

In recognition of my contributions towards cultural, academic, technological and economic exchanges between Japan and Bangladesh for more than 30 years, the Govt. of Japan conferred on me the Emperor's decoration of the "Order of the Rising Sun-Gold and Silver Rays" in November 2004. This has given me the inspiration to live longer and to work more and more for the good causes of Bangladesh and Japan.

### **1. AOTS Dhaka Office and the AOTS Alumni Societies in Bangladesh and Nepal.**

The ex-trainees of AOTS in East Pakistan established ABK Dosokai in Dhaka in 1966 which was re-organized by me in 1972 i.e. a few months after the independence of Bangladesh. The ABK Dosokai was further re-organized and re-named as "AOTS Alumni Association, Dhaka" in 1982 after being inspired by the Post-Hozumi new administration at AOTS HQ within the next one year, the first "Overseas Training Program" on Maintenance of Kubota Diesel Engine was successfully implemented in Bangladesh with the active support of the AOTS Alumni Society in Dhaka. In April 1984, AOTS Dhaka Office was established under the jurisdiction of the General Manager of AOTS Bangkok Office to support the alumni activities and also to expand the AOTS activities like Overseas Training Programs. As mentioned earlier, I was given the responsibility of this office from April 1986. In 1990, the alumni

society in Dhaka was renamed as "Bangladesh AOTS Alumni Society (BAAS)" and a new alumni society was born in the port city of Chittagong in the name of "Chattagram AOTS Alumni Society (CAAS)". Under my active guidance, "Nepal AOTS Alumni Society (NAAS)" was born in Kathmandu in 1991. Following the slogans of "Equal Partnership" and "Self Reliance" as advocated by Mr. Nagaaki Yamamoto, I continued to guide and support BAAS, CAAS and NAAS which became excellent alumni societies in South Asia within a short period. BAAS was able to purchase its own office space in 1993 and NAAS was able to build its own small building in 1995. CAAS was a little bit behind, but was successful to purchase its own office space ten years later. By this time, all of these three alumni societies are completely self-reliant. With the guidance and support of AOTS, BAAS, CAAS and NAAS have been playing a very vital role in developing appropriate human resources in Bangladesh and Nepal not only through the AOTS programs, but also through their own programs like seminars, training courses and WNF Programs in the different areas of national interest. As a result, most of the significant industries and business houses in Bangladesh and Nepal are now having personnel trained by either AOTS or BAAS/CAAS/NAAS at mid, senior and top levels, all of them being connected now through a unique bond called the "AOTS Network".

Simple and basic management techniques of Japan such as 5S, Kaizen, QC Circle, etc. are now widely practiced in both Bangladesh and Nepal enhancing the quality level of the domestic market and also the export potential of these countries. For example, readymade garments and leather products of Bangladesh have recently succeeded to penetrate even into the Japanese market which is extremely quality conscious. Thanks to the retailer giant like UNIQLO which has started using Bangladesh as one of its production bases.

I must mention about one more thing i.e. the "World Network of Friendship (WNF)" which was established as an independent entity for the South-South Cooperation under the support of AOTS. In fact, this entity was born in a different name in 1991 as the "Inter-alumni Resource Exchange Program" when Mr. Nagaaki Yamamoto gave me special permission to use a small fund for inviting one trainee from Nepal to Bangladesh for a 3-week program on "Motorcycle

Maintenance". Since then, the exchange of trainees and experts between Nepal and Bangladesh continued for almost every year using a small fund of AOTS. After several years, "WNF Fund" was formally established with donations from AOTS, Mr. Nagaaki Yamamoto, Lecturers and staff of AOTS, Japanese civilians and the AOTS Alumni Societies and its activities gradually expanded throughout six regions of the world i.e. South Asia, South-east Asia, China, Africa, South America and Europe. At present, this fund is being managed and disbursed by the "WNF Management Committee" consisting of members from six regions and the Secretariat at AOTS HQ and the WNF Programs have been contributing a lot in promoting the "South-South Cooperation" in transferring appropriate technology and management.

## 2. The Birth of Bangladesh-Japan Training Institute (BJTI)

In April 2011, the Bangladesh-Japan Training Institute (BJTI) was born as an independent enterprise of Bangladesh AOTS Alumni Society (BAAS) with the following objectives:-

- (a) To contribute in the economic growth of Bangladesh.
- (b) To contribute in managerial and technical skill of human resources in Bangladesh.
- (c) To disseminate the Japanese Management Approaches in Bangladesh.
- (d) To contribute in the development of industrial relations.
- (e) To establish linkage with similar institutions at home and abroad.

BJTI, a non-profit organization, will be run by an appointed Chief Executive Officer (CEO) under the supervision and guidance of a Council consisting of members from within and outside BAAS. The first council of BJTI has been formed with me as the Chairman and the appointment of the CEO is already under process. To inaugurate BJTI formally, a Kick-off seminar by Prof. Tsuneo Yahagi is now planned for 3 February 2012 in Dhaka under the kind and special support of AOTS. About 100 top business leaders from all over Bangladesh are expected to attend this seminar on "Corporate Management - the Japanese Way".

Meanwhile, to learn from the success stories in Thailand, the Chairman along with a few members of the BJTI Council made a visit to TPA (Technological Promotion Association) and TNI (Thai-Nichi Institute of Technology) in Bangkok on 9.9.2011. The realistic business plan for developing BJTI will be initiated after this visit, but our tentative work plan at this moment is as follows:-

- (a) By September 2011 : To appoint the CEO
- (b) By December 2011 : To sign MOUs of Cooperation with TPA & TNI
- (c) By March 2012 : Develop the Training Courses/ Seminars related to Japanese Management Practices which can be implemented at our renovated BAAS Centre.
- (d) By March 2015 : Procure Land from the Govt. of Bangladesh at an appropriate location for BJTI Campus
- (e) By March 2018 : Construct buildings and facilities at the BJTI Campus with local and overseas donations.
- (f) From April 2018 : Offer short courses, specialized management courses on KAIZEN, TQM, TPM etc. and certain undergraduate courses. Also initiate affiliations with organizations and universities in Japan and other Asian Countries.
- (g) From April 2021 : Offer Postgraduate Courses and Regional Programs as a Centre of Excellence in South Asia.

*Note: 2021 (i.e. 50 years after independence) is the Millennium Goal of the Govt. of Bangladesh to become a Middle Income and Self-sustaining Country.*

In FY 2010, the following special seminars were implemented by AOTS in Bangladesh with special budget from METI:-

- (a) On Drinking Water Purification System in Dhaka, Chittagong and Barguna, about 140 participants.
- (b) On Introducing e-Passbook in the Microcredit System in Dhaka, about 50 participants.

The Overseas Training Programs of AOTS for Bangladesh, specially those for the Garment Sector (by JUKI, Brother, Pegasus, etc.), have been very effective in raising the quality of maintenance of machinery, production management and, of course, the quality of products. As a result, Bangladesh has become a major garment exporting country attracting investments even from Japanese companies like UNIQLO, Matsuoka, Maruhisa, Kojima, Yagi, etc.

## 1.2 New Global Cooperation (NGC) Training Programs of AOTS

Since FY 2010, AOTS introduced several NGC programs, but unfortunately there has been no participation from Bangladesh so far due to the high participation fee for those programs. AOTS is requested to kindly explore the ways and means for drastically reducing the participation fee of the NGC programs so that the participants from the low-income countries like Bangladesh, Nepal, etc. can also attend those programs.

### 1.3 Effectiveness of AOTS Programs

As mentioned earlier, it can be said in general that both Bangladesh and Nepal got immense benefit from the AOTS training programs- both technical and management.

In the 1960s, the technical training programs of AOTS was very useful in building and operating plants (like steel mill, fertilizer factory, paper mill, chemical fiber factory, etc.) in Bangladesh (the then East Pakistan). Those trained people were hired later on for building and operating plants in the Middle-East. During 1970s and 80s, a lot of technicians of the Bangladeshi Dealers of the Japanese Automakers (like Toyota, Nissan, Honda, Mitsubishi, etc.) were sent to Japan under the AOTS training programs. Those people are now nicely supporting the servicing and maintenance of more than 2.0 million Japanese origin passenger and utility vehicles plying over the roads of Bangladesh. In the same way, the Bangladeshi technicians and engineers trained in Japan under AOTS in other technical areas are also contributing greatly in their respective fields. However, the number of technical trainees has decreased drastically during the last 25 years due to the big gap of the technology level between Japan and Bangladesh and the difficulty in finding the training host companies in Japan.

As mentioned earlier that since 1980s, the management training programs of AOTS expanded rapidly with introduction of the cost-sharing system and the need-based programs of shorter duration for the top and executive levels. Since that time, the AOTS trainees from Bangladesh (also from Nepal) have been mostly for the management training programs, some of those being special programs for jointly Bangladesh and Nepal. Some programs have been custom-built for specific sectors such as construction industry, garment industry, etc. The training programs of AOTS have been designed separately for each level of Engineer, Manager, General Manager, Director, Managing Director/ President/ Owner to ensure the effectiveness.

As mentioned earlier, these trained persons are now scattered all over Bangladesh (and also Nepal) making significant contribution to their own organizations and also to the national economy. Many of them tried to adapt simple Japanese management techniques and tools like 5S, Kaizen, TQM, etc. for improving the quality and productivity in their respective

organizations. Some of them succeeded to create success stories with the help of alumni experts. To name a few, the following organizations in Bangladesh are worth mentioning:-

- Bangladesh Power Development Board (a government organization for generating power)
- The Structural Engineers Ltd. (building construction)
- The Partex Group (particle board and beverage manufacturer)
- The Modern Erection Group ( steel fabricators)
- The Padma Cans Group (manufacturers of cans & closures)
- Limo Electronics Ltd. (TV manufacturer)
- Micro Electronics Ltd. (manufacturer of electric devices)
- Oponin Pharma Group (manufacturer of medicines)
- Orion Pharma Group (manufacturer of medicines)
- Healthcare Pharma Ltd. (manufacturer of medicines)
- Aristo Pharma Ltd. (manufacturer of medicines)
- Pacific Jeans Ltd. ( garments manufacturer)
- Urmi Garments Ltd. ( garments manufacturer)
- Niagara Textiles & Garments Ltd. (garments manufacturer)
- DBL Group (garments manufacturer)

It may be noted that Pacific Jeans Ltd. is being used by UNIQLO as a production base. This has been a breakthrough for Bangladeshi garments for entering into the Japanese market.

Similar success stories are also available in Nepal.

### 4 Our Future Expectation form AOTS

The continual growth of AOTS has experienced a setback due to the recent economic and organizational re-structuring in Japan, but AOTS is trying to overcome the situation by introducing innovative ideas and activities. Hopefully, the sunny days are waiting ahead.

Meanwhile, AOTS should further consolidate its

relationship with the AOTS Alumni Network all over the world. AOTS is perhaps the only organization in Japan having such a massive and dependable alumni network which should now be utilized for mutual benefit based on the philosophy of "equal partnership".

Due to drastic appreciation of the Japanese Yen during the recent days, it has become very expensive for the Asian people to participate in the AOTS training programs in Japan. Therefore, AOTS may kindly consider implementing a part of the Management Training Programs (especially those having no government subsidy) at appropriate "Centers of Excellence" (like TPA, TNI, etc.) in Asian countries in order to make those programs more cost effective.

AOTS may kindly consider opening a "Consulting Department" in the near future to start "Collaborative Consulting Activities" with the potential alumni societies all over the world. The combined resources of AOTS (such as the Lecturers of the Management

Training Courses) and specific alumni societies (such as BAAS, NAAS, JASTECA, Chennai Alumni, Mumbai Alumni, etc.) should be good enough to compete in the bidding for specific national projects for management and also to offer Management Consultancy Services to the SMEs in different countries. Through such activities, the AOTS-Alumni Relationship should become stronger and, on top of that, some fund may also be generated for AOTS and the concerned Alumni Societies.

We expect that the existing Agreement System between AOTS and specific Alumni Societies should also continue as long as the government subsidy is available.

We sincerely wish that, based on the experience of last 50 years, AOTS should excel and survive during the next 50 years for creating prosperity, peace and harmony for the world.

## The Big Earthquake and Tsunami of March 11 and “Corporate Management Training” in Japan.

Fortunately or unfortunately, I was in Japan on March 11, 2011 while the big earthquake occurred in Japan. I along with 16 other Nepalese participants were in Japan to attend the “Corporate Management Training” (NPCM-2) from 9 to 22 March in Yokohama Kenshu Center (YKC), Yokohama which was jointly organized by AOTS Japan and the Federation of Nepalese Chambers of Commerce and Industry (FNCCI). We had reached Japan on 8<sup>th</sup> March 2011.

On 9th March, our training started with an orientation program, group photo session and lectures. On 11th March, Friday after lunch around 2:45 p.m. (11:45 Nepali time), while our colleague, Manish Agrawal was making his presentation and Ms. Hiromi Kawai, the interpreter was translating into Japanese, our tables shook strongly. We did not stop the class - the earthquake and the presentation were going side by side. I thought the earthquake was a normal one since I had heard that this kind of earthquake took place frequently in Japan, and from the safety measures seen in the center of the room and all rooms having extra doors, I knew that we could break and run out of the room at anytime. Later, I found out that the earthquake was of a 8.8 Richter scale magnitude with its epicenter in a place called Miyagi Prefecture which was quite far away from we were. The class was postponed for a while to freshen up from motion sickness and resumed again. However, the tremor did not stop, and so all the classes were cancelled at the training center. We gathered in the reception hall in the ground floor for an hour and watched live TV of the effects of the earthquake. We were then asked to shift to the dining room in the first floor due to warning of Tsunami. All of us were quite tense at that time. We informed FNCCI and Nepal AOTS and requested them



to inform our families that we were all safe in Japan. We stayed in the dining room till 7:30 p.m. and then went to our rooms after dinner. Since I could not sleep well, I stayed online surfing the internet till 3 a.m. with family and friends and downloading photos of that day.

the reception on the ground floor, and saw the whole building moving and heard the dangerous swinging sounds. I had never heard seen such a thing in my life. It was a big adventure.

We were assured time to time by the AOTS staffs that the YKC building was constructed for earthquake resistance and was the best place to stay. The reception was the place where all the trainees and staffs of AOTS gathered to pass time easily. During such tremors, staying alone in the room was not our choice.

On the following days too, due to the earthquake and tsunami, the trains were cancelled and our classes were disrupted because the training coordinator and lecturer could not reach the training center. We were not allowed to go to the seaside, so we stayed in the classroom and utilized time by watching management related documentaries and exchanging our experiences among NPCM-2 participants.

From March 11, we felt small as well as big tremors time to time every day. Most of the nights, I spent my time by downloading pictures of the earthquake and informing home online and through emails that we were safe. Even at such times, whenever my fingers touched the keyboard of my laptop, I could not type properly because the laptop and the tables used to shake very much. I used to go to under the table every now and then to save myself. At such times, I could not reply to some of my family and friends who were online because the laptop, the table, the picture frame hanging on the wall of my room were all shaking. I would unlock my door, but due to fear, I left it open and suggested my friends in the other rooms to do the same. They were Chinese, Malaysian and Vietnamese, mostly much younger than me. I still remember one of the friends next to my room who was packing up suitcases and bags, tried to run but fell down in the corridor as the rooms shook very much. I saw her and went to help her. At that time, we were both very emotional.

One night, I felt a big long tremor., and I used intercom to wake up others. We went through the corridor to

One thing that struck my mind during my stay in Japan and also after returning to Nepal was that I was the only female trainee on the 4th floor, which was strictly for female residents only, and all the other 16 members of our group were in the 7th floor. Male residents were not allowed in the floor reserved for female residents and vice versa. But, I think, during such exceptional cases as the big earthquake, such strict rule should not be considered.

However, we trainees and YKC authorities tried our best to continue the training. We could not visit Tokyo and other places in the weekends. The study tour also totally cancelled. On the positive side, the experience of March 11 earthquake in Japan made me feel less tense during the recent earthquake in Nepal. It was said that the experience of rolling blackout (loadshedding) in Japan was the first ever experienced and faced by Japanese people at that time !

On 15th March, we had a class on Marketing Strategy by Mr. Osamu Ueno the whole day from 9 a.m. to 7 p.m. That same day, due to radiation from the nuclear leakage and frequent frantic calls from families of the participants from Nepal asking to return home, we decided to leave Japan. With hopes to fly back home, we went to the airport on 17th March at 5:30 a.m. After 12 hours of effort, we managed to fly from Narita.

- d. Scholarship Guidelines adopted in last AGM has been implemented.
- e. Syed Masud Hassan was nominated as an Adviser. As a result one post of EC Member became vacant. In that place Mr. Golarr Sarwar was co-opted as a Member of EC.
- f. In accordance with the direction of AGM, an EGM was held on 06 November 2010 at All Community Club to consider amendments to the constitution.

# CONSTITUTION OF THE SOUTH ASIA FEDERATION OF AOTS ALUMNI SOCIETIES (SAFAAS)

## NAME

The Federation shall be called “South Asia Federation of AOTS Alumni Societies (SAFAAS)”. A federation of AOTS Alumni Societies of Bangladesh, India, Nepal, Pakistan and Sri Lanka; it shall also apply to Bhutan and the Maldives, in the event of AOTS Societies being established in those countries. “The Federation shall have the authority to appoint special member on the recommendation of the AOTS JAPAN.”

## AIMS AND OBJECTIVES

- To be strictly a non-political voluntary body.
- To unite, enroll and get-together ex-trainees of AOTS and to promote good fellowship, cordial relationship and mutual understanding among their respective countries, to keep them informed of the recent technological developments in Japan and in member countries and to assist in technological and human resources development by jointly:-
- Organizing seminars, conferences, Technical Courses, Training workshops, Japanese language Classes, Exhibitions, etc.
- Exchanging technology in Science and Industry through the exchange of personnel, books, magazines, audio and video cassettes etc., with member countries.
- Exchanging cultural activities such as drama, music, dance, art etc.
- Accelerating the economic development of member countries by promotion various activities and upholding the objectives of its parent body AOTS Japan.
- Promoting goodwill, mutual understanding and friendly relations among the people of member countries through the reciprocation of their cultural and social systems, irrespective of race, religion, nationality or ideological standing.
- Establishing close relationship between Alumni Societies of member countries, Parent bodies, AOTS Japan and AOTS Alumni Societies of other regions to achieve above objectives.

## MEMBERSHIP

The membership of the Federation shall comprise of all the AOTS Alumni Societies of the South Asian Region recognized by AOTS Japan. Each Alumni Society will be represented by three (3) members duly nominated by the Executive Committee of the respective Society.

## PRIVILEGES & DUTIES OF MEMBERS

- Members shall abide by this Constitution and make all endeavors to contribute to the development of the Federation.
- Members shall be entitled to participate in every activity of the Federation.
- Only Federation members shall have the right to vote and to hold office and shall be limited to one vote per member country.

## MEMBERSHIP SUBSCRIPTION

Subscription will be US\$ 100 per year per country. (equivalent to local currency)

## MANAGEMENT

Patron -The Federation shall have as its patron, the Director General of AOTS, Japan

The Executive Board of Management shall comprise of one President one Vice President, one General Secretary, one Treasurer and a Committee consisting of 3 representatives drawn from the total Membership of Federation. Office Bearers shall be appointed by rotation and shall hold office from one AGM to the next AGM.

## AUDITORS

The Books of Accounts of the Federation shall be audited once a year by the Auditors appointed at the AGM of the Federation.

## DUTIES OF THE GENERAL SECRETARY

The General Secretary shall convene all meetings as directed by Executive Board of Management whenever necessary, who shall maintain all records of the minutes of the meetings, valuable documents, letters, etc. And also shall keep members informed of the activities of the Federation regularly.

### **DUTIES OF THE TREASURER**

The treasurer shall maintain Accounts of all moneys received to the credit of Federation. The Treasurer shall submit Statement of Accounts as required by the Executive Board of Management. He shall also submit audited statement of Accounts at the A.G.M.

### **VACANCIES**

Vacancies arising in the course of the terms of the Office of Office Bearers shall be filled by the Executive Board of management from its members for the remaining period of office only.

### **ANNUAL GENERAL MEETING**

The Federation shall have its Annual General Meeting once a year in the host country. In the event of any contingency arising which prevents the holding of the Annual General Meeting in the host country, the Executive Board of Management shall by a majority decision, shift the venue to a convenient location in any member country within the region. The quorum for such a meeting shall be one-third of the total membership.

### **SPECIAL GENERAL MEETING**

The Executive Board of Management shall have the right to convene a Special General Meeting of the Federation as and when it deems necessary by majority decision. Notice shall be given in writing at least 30 days in advance of such meetings.

### **AMENDMENTS TO THE CONSTITUTION**

The amendments to the Constitution may be made at a properly constituted general meeting by a 2/3 majority decisions of the total membership of those who are entitled to vote at such a meeting. Prior notice must be given in writing for such amendments at least 30 days before such a meeting is held. "Except at a SAFAAS Convention where this condition would not be applicable".

### **CONTINGENCIES**

In the event of questions on matters arising which is not specifically provided for the foregoing rules, the decision of the Executive Board of management shall be final, provided such decisions shall not be repugnant to the rules of the Federation.

The delegates of this fourth convention have jointly resolved as follows:

## AICHI RESOLUTION September 1997

Minutes of the meeting of SAFAAS (South Asian Federation of AOTS Alumni Societies) held on September 1, 1997 at the New Chubu Kenshu Centre (CKC) Japan.

The meeting was held under Chairmanship of Mr. M.M. Chowdhury, President SAFAAS Board of management. As per agenda of the meeting, detailed discussions were held and following Resolutions were adopted;

- Resolution adopted in the fourth SAFAAS convention held on 7-8 December, 1995 at Kathmandu, Nepal were read out and approved with following Amendments;
- The Secretariat of SAFAAS will rotate with the President and he will receive the subscription of US\$ 100 in cash for the year 1997-98 for the Alumni societies of SAFAAS region and issue money receipt for the same with the subscription fee so received, He will open a Bank Account in Bangladesh and operate the same jointly with the Treasurer of SAFAAS. He will also maintain proper Accounts of Income and Expenditure of SAFAAS Secretariat and Transfer the surplus amount to the next President on expiry of his term. If FAAAI have received any subscription fee from any Alumni Society and there is amount left from the received amount the same should be transferred to the new SAFAAS Secretariat of Bangladesh with proper income and expenditure account.
- That Nepal AOTS Alumni Society will set up a small cell at Yamamoto Talim Ghar at Kathmandu for monitoring the establishment of SAFAAS Technical and Information Center. They would coordinate with other Alumni Society in this matter since a smaller group would make it easier to manage the activities. Further it was decided that the questionnaire circulated by the Nepal Alumni Society regarding the Technical and Information Centre should be filled up by all the SAFAAS member countries and returned to Nepal Alumni Society so that the technical Centre at Kathmandu could start functioning.
- That the new SAFAAS Secretariat at Bangladesh shall coordinate the inter Alumni Resource Exchange Programmed using forms used by the Western India Alumni Society in order to standardize and centralize this activity in the SAFAA region.
- That to extend inter Alumni Exchange Program outside SAFAAS region SAFAAS Secretariat will make an appeal to the other regional federations to send their specific requirement wherever they would want people from their societies to be trained in the SAFAAS region and also send in their areas of specialization where they are already in a position to accept trainees from the SAFAAS region.
- That expansion of correspondence courses in other SAFAAS countries are not possible now. It was agreed by the member countries to go through FAAAI since JMAM who are the originators of these courses. Wanted to be run through FAAAI would be happy to spread this in countries outside the SAFAAS region also.
- That AOTS Headquarter should be informed that the participation fee for the AOTS management Training Programs is high and the system of calculation is very complicated. It was observed by the members that because of this it was very difficult to Select a right candidate for the training.
- That AOTS should send speakers of overseas lecturing tours who are conversant with English language and the related subject.
- That Mr. Nariman Irani on behalf of the Alumni Societies of Pakistan Confirmed that the second regional business convention shall be held from 5-7, December, 1997 at pearl continental, Karachi, Pakistan and extended and invitation to the participants.
- That the next SAFAAS convention shall be held at Dhaka, Bangladesh Mr. M.M. Chowdhury, President SAFAAS informed that the third Business Convention shall follow immediately after the fifth SAFAAS Convention. The tentative dated for the SAFAAS Convention were agreed to be 27<sup>th</sup> and 28<sup>th</sup> of November, 1998 and 29<sup>th</sup> November for the Business Convention at Dhaka.

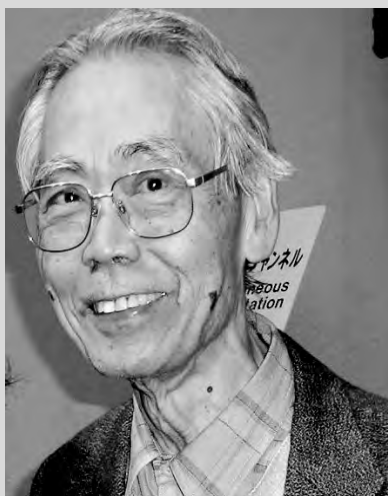

- Proposal of training programs for the regional federation based on the HRD needs of each member country.
- Collaboration amongst the member Societies for evaluation survey sharing data of ex trainees, success stories and co-operation with AOTS.
- Better management of Alumni Societies.
- Mechanism to raise/ generate WNF fund and getting the best out of this program.
- Agreement – how to utilize the agreement for the better relations between Alumni Societies and AOTS.
- The following are the recommendations covering all the 5 topics discussed country wise and consolidated in group discussions.
- Training need of countries have changed and therefore the AOTS training programs should be updated discussions.
- Programs related to service sectors such as banking, telecom and infrastructure, alternate energy resources, supply chain management etc. should be introduced as part of AOTS management training programs.
- A two phase training program should be offered with initial phase of training in member Country / Region and the second Phase in Japan.
- “Training of Trainers” program for accreditation of regional trainers to be organized by AOTS Japan.
- AOTS to consider flexible measures to develop collaborative programs.
- AOTS could explore new area o activities such as distance learning, strategic management etc.
- Inter Alumni, Inter regional cross raining programs for sharing of knowledge of ex trainees between different countries.
- Bi- annual new letter within each Alumni Society should be made available for disseminating information, sharing best practices and success stories.
- Increase of membership in Alumni Societies should be explored by offering special membership to individuals and corporate companies other than AOTS ex- trainees.
- Each Alumni Society should put efforts to enhance its image amongst local industries and other professional bodies for getting their cooperation.
- AOTS Japan could keep the Alumni Societies informed about recruitments of candidates to various management courses through other

professional bodies such as CII, chambers of commerce and industry, Automotive Components Associations etc.

- Alumni Societies should also extend its activities beyond providing not only to AOTS related services but areas such as consultancy services and conducting management training services and conducting management training courses related to quality, productivity etc.
- Alumni Societies should also identify a pool of competent resource persons as trainers for conducting training programs.
- Perdiem allowance for trainees for WNF Programs should be enhanced from 50 US\$ per day to 100 US\$ per day due to high escalation in hotel tariff even among two star category hotels.
- Inter industrial exchange programs among the region may also be encouraged through WNF activity.
- AOTS Alumni Societies agreement form needs to be simplified to workable level, minimum documentation is required to fulfill the needs from AOTS Japan.
- AOTS Alumni Societies of SAFAAS region should undertake the evaluation survey studies based on the format given by AOTS and this study should be completed so that concrete findings can be presented in the AOTS convention in Tokyo in 2009.
- It is proposed to have an exclusive website for SAFAAS for sharing many activities related to each Alumni Society in the region. Lahore Alumni Society will initiate this activity and a representative from each Alumni Society will network with Lahore Alumni Society.
- The convention proposed the next SAFAAS convention to be combined with AOTS 50<sup>th</sup> Anniversary convention Proposed in the year 2009 at Tokyo.
